



Call for applications N° 000003 AAC/ENSPY/EFO-CCAA of 30 JUL 2024 relating to the admission of twenty (20) candidates for an **Advanced Masters in Aircraft Maintenance and Recycling (CAMRA)**.

Organised by the Cameroon Civil Aviation Authority Training School in partnership with VALLAIR Capital SAS (a European group specialised in aircraft airworthiness, maintenance and disassembly) and the National Advanced School of Engineering of Yaoundé, Cameroon.

In line with its mission to support the sustainable development of air transport in Cameroon, the Cameroon Civil Aviation Authority (CCAA) Training School, in partnership with Vallair and the National Advanced School of Engineering of Yaoundé (NASEY) of the University of Yaoundé 1, Cameroon, invite **engineers** aspiring to a career in aircraft maintenance and recycling, and **experienced licenced aircraft maintenance technicians** to apply for the competitive entrance exam for admission into the second batch of the Advanced Masters course in aircraft maintenance and recycling.

The course is open to candidates of all nationalities.

Graduates of this high-level and practical twelve (12) months course, will be qualified to occupy senior management positions in organisations such as:

- Approved Aircraft Maintenance Organisations, including those specialised in aircraft dismantling and recycling;
- Continuing Airworthiness Management Organisations (independent or in an airline);
- Civil Aviation Administrations (Civil Aviation Authorities, Ministries, Accident Investigation Bureaus...); and
- Other related organisations.

The training will be conducted by experienced instructors from the aeronautical industry (pilots, aeronautical engineers, aircraft mechanics, etc.) and lecturers of the NASEY and other universities specialized in the maintenance and production.

Theoretical courses will run from **October 2024** for a duration of nine (09) months at the Cameroon Civil Aviation Authority Training School (EFO-CCAA) located at the

entrance of the Yaoundé-Nsimalen International Airport and on the premises of the NASEY. This will be followed by a three (03) months professional internship in an aeronautical company.

### **a) ENTRY REQUIREMENTS**

- Be a holder of a Masters of engineering degree (MEng) or equivalent in the following fields: mechanical, electrical, electronics, industrial, electromechanical or telecommunications engineering, or
- Be a holder of a Bachelor of Engineering (BEng) or equivalent in the abovementioned fields, and having demonstrated at least two (02) years of continuous engineering experience, or
- Be a holder of an aircraft maintenance technician licence (CAT B1, B2) with at least 05 years of experience in an aircraft maintenance environment.
- Have a good mastery of English and French (spoken and written).

### **b) SELECTION PROCEDURE**

**First phase:** Preselection of candidates based on a personal file review;

**Second phase:** Conduct of written tests;

**Third phase:** Orals in English and French;

**Fourth phase:** Publication of the final list of successful candidates.

### **c) APPLICATION FILE**

Each application file should include:

#### **For Candidates resident in Cameroon**

The registration form is available at [www.efo-ccaa.com](http://www.efo-ccaa.com) and the following documents shall be required:

- A motivation letter addressed **to the Director of the Cameroon Civil Aviation Authority (CCAA) Training School**;
- A certified true copy of the birth certificate;
- A certified true copy of the national identity card, passport, or residence permit;
- A curriculum vitae;
- A medical certificate (regulatory model);
- A certified true copy of the required degree or the aircraft maintenance licence;
- An attestation of presentation of the original of the required degree;
- A certificate of English language proficiency issued by the British Teaching Centre or at a pilot linguistic centre, or a current TOEFL, IELTS or an equivalent language proficiency certificate of **level B1 (intermediate)**. Candidates who obtained their secondary and/or university degrees in the English-speaking educational system are exempted from this requirement;
- A criminal record extract (Bulletin N°3) dated less than three (03) months;
- A 4x4 colour photograph on white background;
- For holders of an aircraft maintenance licence, a copy of their logbook validated by the competent authority;

The code generated following the completion of the online registration form is required to proceed to the payment of the application fees using one of the means of payment indicated.

The non-refundable application fee is **thirty thousand (30.000) FCFA/forty-six (46) euros/fifty (50) US dollars.**

### **For Candidates resident out of Cameroon**

The registration form is available at [www.efo-ccaa.com](http://www.efo-ccaa.com) and the following documents shall be required:

- A motivation letter addressed **to the Director of the Cameroon Civil Aviation Authority (CCAA) Training School;**
- A copy of the birth certificate;
- A copy of the identification document (national identity card or passport)
- A curriculum vitae;
- A medical certificate;
- A copy of the required degree or the aircraft maintenance licence;
- A certificate of English language proficiency issued by the British Teaching Centre or at a pilot linguistic centre, or a current TOEFL, IELTS or an equivalent language proficiency certificate of **level B1 (intermediate)**. Candidates who obtained their secondary and/or university degrees in the English-speaking educational system are exempted from this requirement;
- Two (02) 4x4 colour photographs;
- For holders of an aircraft maintenance licence, a copy of their logbook validated by the competent authority;

The code generated following the completion of the online registration form is required to proceed to the payment of the application fees using one of the means of payment indicated.

The non-refundable application fee is **thirty thousand (30.000) FCFA/forty-six (46) euros/fifty (50) US dollars.**

### **d) APPLICATION DEADLINE AND LOCATION**

Applications must be submitted no later than **11:59 p.m (GMT+01)** on **August 30<sup>th</sup>, 2024.**

#### **NB:**

- (1)** Incomplete, non-compliant or late applications will not be examined.
- (2)** Only the shortlisted candidates after the review of applications, will be admitted to the competitive examination.
- (3)** Shortlisted candidates resident in Cameroon are required to come along with physical copies of their application on the day of the exam.

### **e) DATE AND PLACE OF COMPETITIVE ENTRANCE EXAMINATION**

The written and oral tests will take place at the CCAA Training School located at Yaoundé-Nsimalen International Airport **from September 11 – 12, 2024, from 08 a.m.**

### **f) ASSISTANCE ON ARRIVAL FOR FOREIGN CANDIDATES**

Shortlisted candidates residing out of Cameroon shall indicate their travel itinerary by e-mail to [training.school@ccaa.aero](mailto:training.school@ccaa.aero) for assistance upon arrival. Accommodation

arrangements are the responsibility of the participants; however, the Training School is available for assistance.

### h) TUITION FEES

Tuition fees amount to **two million five hundred thousand (2,500,000) FCFA** for Cameroonian students and **three million five hundred thousand (3,500,000) FCFA** for foreign students, payable in instalments.

Civil Aviation Authorities, aircraft operators, approved maintenance organizations and other aviation organizations who desire to register their staff for the training should contact the CCAA Training School for validation of their candidates or assistance in the preselection of candidates.
